Vendor has to submit the following details/certificates/undertaking along with other documents **IN THEIR TECHNICAL BIDS (except the price bid which is to be given in the amended Annexure-VI given below for Canteen Price List and to be submitted as Price Bid i.e., Part-II Bid in a separate Sealed Price Bid Envelope).**

NOTE-

In the amended Annexure-VI for Canteen Price List and to be put in a separate sealed envelope, the vendor has to quote the basic unit rates (without any taxes) in the basic unit rate column and extra applicable GST (as per the rate applicable to the vendor) in the GST Rate Column i.e.

_____ % IGST

or

_____ %CGST + _____ %SGST.

Vendor has to mention the percentage applicable GST in the price bid (Part -II Bid) otherwise their offer will be liable for rejection. Total landing rates will be basic rate quoted plus GST quoted by the vendors as per GST rate applicability to the vendors. Offers with old tax structure are liable to be rejected.

- 1) Since GST has been implemented w.e.f 01/07/2017 as per central Govt., hence ED, CST & Service Tax are no more applicable. Vendors are requested to submit their offers as per GST tax structure only.
- 2) Vendor shall submit a undertaking that he has followed the provisions of Section 171 of CGST Act and benefit of GST (Input Tax credit due to anti profiteering scheme under GST regime) has been passed on to IPGCL/PPCL in their offer against this case by way of commensurate reduction in prices. Format of undertaking is as :

- 4) The vendors who have already submitted their offer along with EMD, they need not submit the EMD again, however they must submit, latest by the extended due date, only their revised Price Bid in the **amended Annexure-VI for Canteen Price List** format given below in a separate sealed envelope (marked on the face of envelope as "Price Bid Envelope").
- 5) Any old taxes such as service tax, ED, VAT etc. mentioned in the tender document may be read as GST as per current GST tax structure.
